***Item 1. Security and Issuer.***

The statement relates to the Common Stock, \$0.001 par value per share ("Common Stock") issued by Lucas Energy, Inc., a Nevada Corporation (the "Company"), whose principal executive offices are located at 3000 Richmond Avenue, Suite 400, Houston, Texas, 77040.

***Item 2. Identity and Background.***

This statement is filed by James J. Cerna, Jr., an individual ("Reporting Person"), whose principal offices are located at 3000 Richmond Avenue, Suite 400, Houston, Texas, 77040.

The Reporting Person has not, during the last five (5) years (i) been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors), or (ii) been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violations with respect to such laws.

***Item 3. Source and Amount of Funds or Other Considerations.***

The Reporting Person acquired 3,377,210 shares of the Company's stock in exchange for funds tendered to the Company's wholly-owned subsidiary and for services as a founder of the subsidiary company. The shares are held by the James J. Cerna Revocable Trust, of which the Reporting Person is the Trustee.

***Item 4. Purpose of Transaction***

The purpose of the transaction in the stock is investment. Additionally, no changes will be made to the issuer's charter, bylaws or instruments corresponding thereto.

***Item 5. Interest in Securities of the Issuer.***

COMMON STOCK

As of the date hereof, the Reporting Person beneficially owns 3,377,210 shares of the Company's common stock, comprising 12.44% of the issued and outstanding common stock of the Company. The percentage used herein is calculated based upon the 27,140,013 shares of Common Stock of the Company stated by the Company as issued and outstanding as of July 13, 2006. The Reporting Person has sole voting and dispositive powers with respect to 3,377,210 shares of Common Stock which he owns and which are held by the James J. Cerna Revocable Trust, of which the Reporting Person is the

Trustee. The Reporting Person has not effected other transactions in the shares of the common stock.
